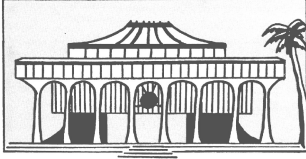


## Keep Abreast of What the Legislature Is Doing to You



With the dire state of our economy, the quest to generate revenue to run state government will be a top priority for lawmakers as they attempt to maintain funding for essential services and programs. In addition to the status of tax measures, legislative monitors from various areas of interest to business will be invited to share their issues with members. Among the areas which may be included are labor issues, insurance proposals, and concerns of the transportation and visitor industry.
