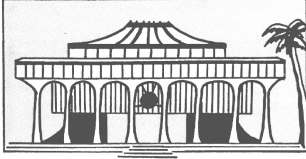


Keep Abreast of What the Legislature Is Doing to You



Will the 0.5% county surcharge for rail be extended or made permanent? What will happen to the income tax rates and adjustments scheduled to expire at the end of 2015? Will there be a new tax on sugary drinks? Or will the new administration hold the line to control the growth of state government? Come and find out the answer to these issues and more at the Tax Foundation of Hawaii's Legislative Briefings.

In addition to the status of tax measures, legislative monitors from various areas of interest to business will be invited to share their issues with members. Among the areas which may be included are labor issues, insurance proposals, and concerns of the transportation and visitor industry.
